President O’Shea opened the meeting at 6:00 p.m. with the Pledge of Allegiance, followed by a Moment of Silence. Announcements were made in accordance with Mass General Law, and it was noted that ELCAT was taping the meeting.

**Council Comments:** President O’Shea thanked the DPW for all their hard work with snow removal due to winter storm Fern.

**Town Manager Report:** Town Manager Tom Christensen gave his report as shown in Attachment A.

Councilor Page wanted to remind residents with fire hydrants in front of their homes that if they have the ability to clear the snow it would be helpful and greatly appreciated by the Fire Dept. Councilor Page also mentioned that in the past DPW had asked about the possibility of using Brown farm for storage of snow as there parking lot in mostly unused in the winter.

1. Accept \$1,000 donation from Bay Path University to support the East Longmeadow Fire Department, per Massachusetts General Law Chapter 44, Section 53A.

Councilor Page seconded the motion. **Roll Call Vote – President O’Shea – Yes, Councilor Leydon – Yes, Councilor Hill – yes, Councilor Richards- Yes Councilor Page – Yes and Councilor Torcia – Yes.**

2. 2025 Annual Town Employee wage transparency

President O’Shea gave an update that the 2025 wage transparency report was completed and is now on the website. This is shown in attachment B.

**Approval of Minutes:**

1. Approve January 13, 2026 Open Session Minutes.

Councilor Page moved to approve the January 13, 2026 open session minutes Councilor Leydon seconded the motion.

Councilor Richards moved to amend the motion to provide an adequate summary for the discussion regarding center town district. There was no second to this motion. Councilor Page suggested postponing acceptance of the minutes until the next meeting. Councilor Page rescinded his motion to approve the January 13, 2026 Open Session minutes. Councilor Leydon rescinded his second.

2. Approve January 13, 2026 Executive Session minutes.

Councilor Richards made a motion to approve the January 13, 2026 executive session minutes Councilor Torcia seconded the motion. **Roll Call Vote – President O’Shea – Yes, Councilor Leydon – Yes, Councilor Hill – yes, Councilor Richards- Yes Councilor Page – Yes and Councilor Torcia – Yes.**

**Old Business:**

1. 250<sup>th</sup> Anniversary

The Council agreed that they would discuss this at the next meeting due to the passing of Tom Behan who was heavily involved in Anniversary plans. Getting a price on banners was discussed as well.

2. Proposed Charter Amendment relative to multiple bylaw changes simultaneously  
President O’Shea gave a brief summary of the bylaw.

Councilor Leydon made the following motion: that the Town of East Longmeadow, Home Rule Charter be amended by removing the last paragraph of Article 2, Section 2-6, Town Bylaws, and replacing it with the following language:

Notwithstanding the above, the revision or recodification of general bylaws and related legislation commenced by the Town Council pursuant to Article 9 ,Section 9-3 of the Charter, along with any qualifying amendments or new bylaws proposed as part of that process, may be voted on as a single subject being proposed. Any vote pursuant to Article 9, Section 9-3 shall be preceded by the publication of a reasonable synopsis of the proposed changes in a local publication or newspaper at least 14 days prior to any such vote. A comprehensive record reflecting the entire scope and contents of the changes shall be available for review in the office of the Town Clerk and on the Town website at least 14 days prior to any such vote on the proposed changes. Any proposed recodification will not require the use of strike-out type, brackets or underscoring as set forth herein for reformatting, renumbering, and re-titling existing sections and making grammatical changes. Any proposed changes, additions, or removal of language to the bylaws shall require the use of strike-out type, brackets, underscoring, or marginal notes in such a way as to clearly identify the changes being proposed. Approval of any qualifying amendments or new bylaws shall require an affirmative vote of a majority of the full Town Council, except as otherwise provided by the General Laws or this Charter. Nothing in this paragraph shall relieve the Town or Town Council of its obligations to comply with all applicable state laws regarding approval or amendment of bylaws, including specifically, compliance with Massachusetts General Law Chapter 40A, with respect to any and all zoning bylaws. Ralph seconded the motion. **Roll Call Vote – President O’Shea – Yes, Councilor Leydon – Yes, Councilor Hill – Yes, Councilor Richards- Yes, Councilor Page – Yes and Councilor Torcia – Yes.**

3. Proposed Annual Town Election ballot question relative to recreational marijuana.

President O’Shea went through the timeline. It had been originally thought that we needed to have a ballot question to ask the voters to either confirm or overturn what had originally been voted on by the voters back in 2017 to prohibit the sale of recreational marijuana in East Longmeadow. Since the voters originally enacted the prohibition.

After subsequent opinion by the town's legal counsel, it was then determined that we did not have to do that because the Mass General law only requires the ballot question if you're prohibiting it. It makes no determination if you're not prohibiting it and therefore kind of reversing a prohibition that you have to seek voter approval to do so.

This Council had felt that it would be appropriate, given that it was it wasn't a close call back in 2017 that we wanted the public's input on the question. The Council decided that they wanted to proceed with a non-binding question so they would still be asking the public for their input before voting on the topic. Because we are at ballot question time deadlines.

President O'Shea wanted to see if the Council wanted to add that as a non-binding question to the ballot on the June 2nd, 2026 Local Election for the voters to say yes or no. The Council will meet with legal and come up with an appropriate ballot question that is simple and easy to understand and then make a decision at a future meeting as to whether or not it will be added to the ballot.

#### **New Business:**

1. Time Capsule - Tabled until next meeting.
2. Proposed bylaw, Chapter 328 – Right to Farm – first reading

Councilor Page proposed a Right to Farm bylaw and gave an overview of what that would mean for the town. Councilor Page Read the proposed bylaw into the record as shown in attachment C.

Councilor Hill made a motion to send the proposed bylaw, Chapter 328, Right to Farm, to the Bylaw Review Committee for their review and recommendation to the Town Council. Councilor Leydon Seconded the motion. **Roll Call Vote – President O'Shea – Yes, Councilor Leydon – Yes, Councilor Hill – yes, Councilor Richards- Yes Councilor Page – Yes and Councilor Torcia – Yes.**

3. Proposed zoning bylaw amendment relative to farming – first reading

Councilor Page is in the process of crafting a bylaw in regards to agriculture and the and the definition of agritourism. He asked for input from the Council as to the zoning and what the town would or would not like to allow. Examples being corn mazes, event barns, hay rides and other similar activities. Councilor Page will work on the bylaw and bring it before the council for review before handing the proposal over to the Planning Board.

Councilor Page made a motion to close the Open Session meeting. Councilor Hill Seconded the motion. The vote was 6 in favor and 0 opposed.

Good evening:

Attached please find project reports for the weeks of January 5<sup>th</sup>, January 12<sup>th</sup> and January 19<sup>th</sup> regarding the construction of the high school and natatorium. I know I probably sound like a broken record at this point, but the progress of this construction project has been remarkable from week to week. The transformation of the site has been fun to watch in real time. Most of the country was interrupted this weekend due to Winter Storm Fern that dumped almost 20 inches of snow here in East Longmeadow. Thank you, as usual, to our amazing DPW for a job well done. The aftermath of a storm like this is a whole other project so we do ask that if you have questions or need to report an issue, please call the DPW office (525-5400 Ext 1200) so they can prepare a work order. This will ensure that all calls are tracked, assigned and closed out when completed. This process lends to organization and much needed data for the efficiency of the operation. Please be patient in the coming days as we continue cleaning up intersections, hauling snow and processing work orders from the storm.

Kim, Rebecca and I attended the MMA Annual Meeting, aptly named Connect 351, that was held in Boston from January 22<sup>nd</sup> through the 24<sup>th</sup>. Some 1400 local leaders from across the Commonwealth descended on the Thomas Menino Convention Center for workshops, a trade show and guest speakers, including Governor Healey and Lt. Governor Kim Driscoll. The keynote speaker was Dr. Tim Shriver, who gave a message about communicating and the importance of maintaining dignity through discussion. The Governor also gave us some good news about the budget including the additional Chapter 90 funding level we saw last cycle and a 4.4% increase in state aid. Thanks to the MMA for another well run and informative event.

Speaking of the budget, level 1 budgets were submitted at the end of last week and we will begin compiling them into a working document. We will meet with all the department heads and have a pretty good overview of what the budget will look like for FY27.

It is with great sadness that I announce the passing of our Historical Commission Chairman, Tom Behan. Our thoughts and prayers are with his family at this difficult time. There are many things I could say about Tom, perhaps all that matters is that those of us who were fortunate to have had the pleasure to be around him will miss his kind soul, warm smile and his genuine love for his community and everyone in it. He will be greatly missed.

**s/s 328-1 Legislative purpose and intent.**

In East Longmeadow, where farming is an essential part of the town's history, farming continues to be a necessary and desirable activity that provides food, clean air, economic diversity, local employment, cultural and recreational activities and open space for all citizens of our community.

The purpose and intent of this By-law is to state with emphasis the Right to Farm accorded to all citizens of the Commonwealth under Article 97 of the Massachusetts Constitution and all state statutes and regulations thereunder including but not limited to Massachusetts General Laws Chapter 40A, Section 3, Paragraph 1; Chapter 90, Section 9; Chapter 111, Section 125A; and Chapter 128, Section 1A. We the citizens of East Longmeadow restate and republish these rights pursuant to the Town's authority conferred by Article 89 of the Articles of Amendment of the Massachusetts Constitution ("Home Rule Amendment").

This General By-law encourages the pursuit of agriculture, promotes agriculture-based economic and employment opportunities, and protects farmlands within East Longmeadow by allowing agricultural uses and related activities to function with minimal conflict with abutters, and Town agencies. This Bylaw shall apply to all jurisdictional areas within East Longmeadow.

**s/s 328-2 Farm, Farming activities, Agriculture or Agricultural activities**

The word "farm" shall include any parcel or contiguous parcels of land, or water bodies used for the primary purpose of agriculture. The words "farming" or "agriculture" or their derivatives shall include, but not be limited to the following:

- Farming in all its branches and the cultivation and tillage of soil;
- Dairying
- Production, cultivation, growing and harvesting of any agricultural, aquacultural, floricultural, viticultural, or horticultural commodities.
- Growing and harvesting of forest products upon forest land, and any other forestry or lumbering operations
- Raising livestock including horses:
- Keeping horses as commercial enterprise.
- Keeping and raising of poultry, swine, cattle, ratites (such as emus, ostriches and rheas) and camelids (such as llamas and camels), and other domesticated animals for food and other agricultural purposes, including bees and fur-bearing animals.

**"Farming"** shall encompass activities including, but not limited to, the following:

- Operation and transportation of slow-moving farm equipment over roads within the Town.
- Control of pests, including, but not limited to, insects, weeds, predators and disease organism of plants and animals.
- Application of manure, fertilizers and pesticides.

- Conducting agriculture-related educational and farm-based recreational activities, including agri-tourism.
- Processing and packaging of the agricultural output of the farm and the operation of a farmer's market or farm stand including signage thereto.
- Maintenance, repair, or storage of seasonal equipment, or apparatus owned or leased by the farm owner or manager used expressly for the purpose of propagation, processing, management, or sale of agricultural products.
- On-farm relocation of earth and the clearing of ground for farming operations.
- Construction and use of farm structures and facilities for the storage of animal waste, farm equipment, pesticides, fertilizers, agricultural products and livestock, for the processing of animal waste and agricultural products, for agritourism, for the sale of agricultural products, and for the use of farm labor, as permitted by local and state building codes and regulations, including construction and maintenance of fences.

### **s/s 328-3 Right to Farm Declaration**

The Right to Farm is hereby recognized to exist within the Town of East Longmeadow. The above-described agricultural activities may occur on holidays, weekdays, and weekends by night or day and shall include the attendant incidental noise, odors, dust, and fumes associated with normally accepted agricultural practices. It is hereby determined that whatever impact may be caused to others through the normal practice of agriculture is more than offset by the benefits of farming to the neighborhood, community and society in general. The benefits and protections of this By-law are intended to apply exclusively to those agricultural and farming operations and activities conducted in accordance with generally accepted agricultural practices. Moreover, nothing in this Right to Farm By-law shall be deemed as acquiring any interest in land, or imposing any land use regulation, which is properly the subject of state statute, regulation, or local zoning By-law.

### **s/s 328-4 Disclosure Notification to Real Estate Buyers**

To allow prospective purchasers to make informed decisions prior to a real estate transaction and to promote harmony between farmers and their new neighbors after a transaction, the Town of East Longmeadow requests selling landholders and/or their agents (and assigns) provide written notice to prospective purchasers substantially as follows:

“It is the policy of the Town of East Longmeadow to conserve, protect and encourage the maintenance and improvement of agricultural land for the protection of food and other agricultural products, and for its natural and ecological value. This disclosure notification is to inform buyers that the property they are about to acquire lies within a town where farming activities occur. Such farming activities may include, but are not limited to, activities that cause noise, dust and odors. Purchasing, and henceforth occupying land within East Longmeadow means that one should expect and accept conditions as a normal and necessary aspect of living in East Longmeadow.”

Written notification may occur in one of several ways including but not limited to a disclosure form, addendum to a Purchase and Sale Agreement and should include an acknowledgement by the buyer that they have received notification.

### **s/s 328-5 Resolution of Disputes**

Any person who seeks to complain about the operation of a farm may, notwithstanding pursuing any other available remedy, file a grievance with the Zoning Enforcement Officer, the Board of Health, or the Town Manager, depending upon the nature of the grievance. The filing of the grievance does not suspend the time within which to pursue any other available remedies that the aggrieved may have.

### **s/s 328-6 Severability Clause**

If any part of this By-law is for any reason held to be unconstitutional or invalid, such decision shall not affect the remainder of this By-law. The Town of East Longmeadow hereby declares the provisions of this By-law to be severable.
