**Superintendent's Report:**

5.1 Mr. Smith gave an update on the ELPS Outreach and operations during closure from Covid-19. ELPS is/and has been actively learning remotely since March 18<sup>th</sup>. Parents and students know when assignments are coming on specific days of the week. Classes will be meeting live (Google hangout and zoom), videos and so forth. This has been ongoing for the past two weeks. This is a whole new way to operate. Different stress on staff and families. Overwhelmingly, our outreach and what we have been doing, has been positive and hopefully provided a boost to families. Looking for a recognized break coming up at the end of this week. Monday being a holiday, and spring break.

Gregory: To reiterate from a parent perspective, the students are engaged in home learning now. The staff is doing a fantastic job adapting how they are instructing the students. It's been good to see how quickly ELPS has stepped up to this challenging endeavor.

5.2 ELPS Student Opportunity Plan for 2021-2023 was presented by Ms. Brown, Dir. of Curriculum.

Mr. Smith: This is a plan that comes from the Student Opportunity Act, looking at bringing reforms, changes and revisions to the Foundation Budget Reform. How we do a better job funding districts specifically special education costs. Also making it more equitable for all districts across the Commonwealth. For ELPS, it allows us to continue to do some of the work we have already started with the Diversity and Equity Steering Committee. We were not one of the districts that received a huge amount of funding from the Student Opportunity Act.

Ms. Brown: The Student Opportunity Act allows us to identify groups of students who require focus support. We conducted an Equity Audit; we determined that there is clear inequity in enrollment in advanced academics and postsecondary readiness for students with disabilities, ELL students, economically disadvantaged students and students of color. We found two underlying causes: lack of diverse staff and need for inclusive, culturally responsive teaching practices. Our focus will be on: Diversifying our educator workforce and increase services to support holistic student needs. Next year we plan on purchasing PanoramaEd's Student Success Dashboard to streamline screening and tracking progress across academics, attendance, behavior and social emotional learning. This may help the District to quickly identify students who may be experiencing challenges. We plan on partnering with NCCJ (National Conference for Community and Justice) to deliver PD that will help our staff examine systems of oppression and privilege and learn culturally responsive teaching techniques and ultimately create a more inclusive classroom. DESE also requires us to have certain Metrics that we are going to use to monitor success. And lastly, engaging all families. Given our focus on student subgroups, it is particularly important that we find ways to effectively engage our families of students of color, student from low-income backgrounds, English Language Learners and students with disabilities.
