

**WHEN SHOULD THIS FORM BE FILED:**

Such reports shall be filed

- (1) on or before the eighth day before the election (complete through the eighteenth day prior to the election)
- (2) on the thirtieth day following the election (towns only)
- (3) a year end report due by January 20 of each year (complete through December 31,) if liabilities exist
